



#### LBRP History

Total: \$334.5 million in bond funds 975 bridges replaced Avg - \$343,000 per bridge

# Local Bridges – Priority / Waiting List

- Master Local Bridge Priority List (5 year priority: 2017-2021)
  - Bridges identified by local agencies as priority for replacement within their 5-year capital improvement program
  - 923 bridges requesting \$245 million in bond funds
- Local Bridge Waiting List (as of November 2017)
  - Bridges that have been designed and approved or are in the process of design
  - 98 bridges requesting \$52 million in bond funds

# **LRIP** Competitive Solicitation

- Available funding \$25,366,000
- Counties and state aid cities applications due Nov 3 (\$1M max)
- Small cities and townships applications due Dec 1 (\$750K max)
- Funding splits:
  - County 30%
  - SA City 30%
  - Small City 30%
  - Township 10%

#### Unified Permitting Process (UPP) – Oversize/Overweight




# Unified Permitting Process (UPP)

#### • Question:

 Trucker A wants to haul an overweight piece of equipment from East Grand Forks in Polk County to a Red Lake County gravel pit outside of Plummer. How many agencies does he need to contact to get a permit from to make that trip?

#### • Answer: 5

- City of East Grand Forks
- Polk County
- MnDOT
- Red Lake County
- Emardville Township



# **Unified Permitting Process**

- Goal One Stop Shop for Oversize / Overweight Permitting
  - Seems easy. Just like Google maps.
- Three key things to address:
  - Data needs
  - Technology
  - Agency approval process
- At least 3-4 years away from implementation
  - Phase 1 complete
  - Phase 2 on-going (end product likely a pilot project in NE MN) 2017-2018
  - Phase 3 utilize results of pilot to develop a tool 2019-2021
