^{**}Article 2, Section 12 allows for the commissioner of commerce to delay, stay, or waive licensing, investigative, or other deadlines to provide relief or safe harbor from legal obligations with respect to licensees or other persons regulated by the Department of Commerce. This has potential to delay the receipt of a variety of license and application fees, and will have an unknown fiscal impact, but could affect various funds. The receipt of various affected fees may be pushed back from FY 2020 to FY 2021.

^{***}There is a revenue reduction of \$14,000 in FY22 and \$14,000 in FY23 for the State Government Special Revenue Fund and a revenue reduction of \$540,000 in FY22 and \$540,000 in FY23 for the Opioid Response Fund, as indicated by "ongoing" in lines 43 and 44.

^{****}Article 2, Section 15 allows for the extension of the expiration dates of valid driver's licenses. This will result in a revenue reduction, estimated to be less than \$600,000, in FY 2020 and an equivalent revenue increase in FY 2021.
