



Summary of 2023 LRIP Competitive Solicitation Selected Projects



- 86 LRIP Projects Awarded Funding (\$102.967M)
 - 83 Local Agencies
 - 17 projects under construction or construction ready
 - 3 Federally Recognized Indian Tribes
- No funding remaining

2025 LRIP Competitive Solicitation

- 2025 LRIP Appropriation:
 - \$47M available in GO bonds
 - Maximum Selection: \$1.5M

- Counties, cities, towns are eligible
- Capital construction costs; no required local match



Summary of 2023 & 2025 LBRP Funding


- \$85.013M appropriate in 2023
- 192 Projects Awarded Funding
 - 185 construction ready, under construction, or complete
- Wait List started October 22, 2024

- \$20M appropriated in 2025
- 39 Projects Awarded Funding
 - 8 construction ready or under construction
- No funding remaining
- Wait List started October 24, 2025





Summary of AT Infrastructure Solicitations


Active Transportation (AT) Infrastructure Program 2024 Project Selections



- 2024 Infrastructure Solicitation (\$12.502M); Greater MN
 - 24 Local Agencies
 - 1 Federally Recognized Indian Tribes
 - All funding allocated
- 2025 Appropriation = \$5.439M
 - Next infrastructure solicitation planned for fall 2026 with \$4.3M
 - Capital construction costs; no required local match
- On-going base budget target for the AT program ~ \$8.2M/yr

Safe Routes to School (SRTS) Infrastructure Program


- City of Richfield SRTS project
 - 2023 selection; \$534k SRTS funds (\$624k total cost)
 - Grade-separated bike lane
 - On-street bike lane
 - Sidewalk
 - Curb extensions/ADA ramps



Summary of SRTS Infrastructure Solicitations

Safe Routes to School (SRTS) Infrastructure Program 2024 Project Selections



- 2024 Infrastructure Solicitation (\$10.285M)
 - 21 Local Agencies
 - 2 Federally Recognized Indian Tribes
 - All funding allocated
- No 2025 Appropriations
 - If funds appropriated in 2026, next infrastructure solicitation planned for fall 2026
 - Capital construction costs; no required local match
